Another fantastic year for SCA (Qld)!

I want at the outset to thank you all for your support in the role of President of SCA (Qld). I am a people person and I am exceedingly proud of being able to lead our people centric industry. It has been a year of achievement and growth for our industry; and yet we are likely on the precipice of a decade of even more impactful growth and this will likely be looked back upon as merely a foundation for that which is to come.

SCA (Qld) has continued to grow, the number of strata lots in Queensland has continued to boom, and overall the strength and professionalism of the industry continues to flourish. SCA (Qld) held a total of 320 educational events this year with close to 7000 registered attendees. The calibre of people joining the strata industry in the modern era is impressive to see and the overall commitment to education and professionalism shown by our members has been sensational. The facilitators and staff at SCA (Qld) continue to deliver a first-class educational product to ensure that CPD is not just an obligation but something our members use to enhance their personal and professional lives, and those of their clients.

I would like to thank all my colleagues on the board, who have devoted their passion, time and intellect to the task of advancing our industry. I am so proud to lead our industry with you. The passion, breadth of experience and knowledge which each of you bring is a sight to behold. Strata has some of the keenest and most enthusiastic minds sitting at its helm and I am honoured to sit among them.

This year's conference had a record attendance of 320 and I was impressed to see the commitment of delegates to the theme of "Level Up." Our collective commitment to client experience and service is what makes SCA (Qld) such a great organisation to be a part of and this was evident as everyone sought to raise their standard from the content delivered over the two days.

Whether it was the leadership retreat in Hobart, the Christmas networking or our roadshow, SCA (Qld) events were well attended with positive feedback for members. The ability to network – despite the obvious social aspect – is crucial to our development as professionals. Meeting other strata professionals helps create a synthesis of best practice and new ideas. These events build a professional collegiality and camaraderie that is critical to our industry as a whole. SCA (Qld) had significant advocacy wins in the areas of combustible cladding, the Northern Australia Reinsurance

SCA (Qld) had more direct meetings with Government than ever before, pushing our case directly to the decision makers in the state and federal parliaments. This work is time consuming but our advocacy team never wavered from the task. We believe the next twelve months will represent the fruits of our labour in this regard and be remembered as a year of achievement and transformative change.

Whilst COVID-19 is perhaps here to stay in a way, I want to commend how our members managed the final phase of the pandemic, particularly the soft lockdown of the first couple of months of the year. You have all dealt with this difficulty tremendously over the past couple of years, and it is important to note how much more difficult the increased time at home made life for strata managers. Nevertheless, you persisted. And you can look back and be proud of the adaptive approaches you've taken to look after yourself, your family, your team, and your clients. GENERAL MANAGER'S

REPORT



SCA (Qld) farewelled long-time General Manager Katrin Watson on June 30, 2021, and I began my time as the new, permanent General Manager on June 10 2022. SCA (Qld) spent a long time with interim arrangements, and I commend the diligence of the board and staff in ensuring as minimal disruption as possible.

Having recently got my feet under the desk, I am pleased with the quick progress we have made in driving fresh positive change within the organisation. With such a broad remit, it is pleasing to see SCA (Qld) kicking goals across the board. I have sought to bring the best of my 30 years' experience across member-based organisations to the fore and implement positive changes to how we do things.

From the outset, I have pushed a more proactive approach to member engagement and communication, with weekly updates about key issues titled "The Six Pack", a monthly Advocacy Update plus our monthly State Update. I have also encouraged an enhanced presence on social and professional networking platforms. I believe keeping members informed about our diligent work on their behalf is critically important.

I have a background in Government relations and am particularly delighted to join an advocacy team that kicks goals. 





COMMUNITY

ENGAGEMENT

Public Reach

COVID-19 was still a challenge for all over the past year, and SCA (Qld) worked diligently to keep members informed of changes to regulations, restrictions and best practice. The nuances of body corporate and its collective decision-making mean that COVID-19 was a particularly difficult beast to manage. SCA (Qld) appeared at the parliamentary inquiry into the end of the vast majority of special COVID-19 Legislation. SCA (Qld) kept members in the loop at every step of the way and put out several member alerts and worked diligently to ensure members understood their rights and obligations. Keeping members abreast of key issues is a big part of what SCA (Qld) does. To this end, we have now committed to a monthly advocacy update where necessary to help keep members abreast of issues as they arise.





Media

SCA (Qld) had a tremendous year for media, with record amounts of coverage. 2022 started off with a media bang as the now infamous Artique adjudication occupied significant mainstream media coverage. In one day SCA (Qld) had several directors making appearances on radio, television and in print. Several articles continued to flow for some days afterward. Commendation must go to the SCA (Qld) board directors Shane Devenish, Kristi Kinast, Jason Carlson and Chris Irons, all of whom stepped up and appeared live on air across a host of mediums. SCA (Qld) also got national media coverage about strata reform in the lead up to the Federal Election around strata as a solution to the housing crisis. The political machinations around the Northern Reinsurance Pool and our comments around this also got extensive print and radio coverage. We also got significant coverage on Sky News and ABC around combustible cladding. with Senior Vice-President Chris Irons featuring on prime-time radio. Kristi Kinast as President became somewhat of a regular on ABC radio across the state commenting on various issues and she must be commended for her willingness to always step up and speak on behalf of our industry.

The Market

With Queensland continuing to be the prime choice for Southern migrants despite the COVID-19 pandemic casting a large shadow over the financial year, lot growth seemingly cannot keep pace with demand. Real estate prices soared and despite the significant issues facing our construction sector, strata continued to grow, with a 1.57 % increase in lots over the year. This is a significant result given the disruption to the building sector. With interstate migration extremely strong to Queensland and this trend set to continue, it is likely that pent up demand will see an explosion of lots in coming years. Queensland is the place to be and increasingly, strata will be a first choice and an only option. Brisbane unsurprisingly led the way with 64 new schemes being registered over the past 12 months.





MEMBERSHIP

Our members are the backbone of who we are at SCA (Qld). Our membership offering continues to increase with a greater diversity of events and services and a renewed sense of collegial collaboration that has been one of the positive outcomes of the recent Covid years.

The SCA (Qld) membership continued to grow last year as the level of engagement increased. We are still on a very positive growth trajectory, continuing the enviable trend that we have been fortunate to experience over the last 10 years.

As an association, SCA (Qld) is built a little differently to others in that we are a true community and an engaged membership. Our members are active in every sense, and volunteer their time to better the sector, while at the same time developing their own professional credentials and leadership capability. It is fair to say that SCA (Qld) is growing with our membership.

Growing and supporting our members in any way we can continues to be key for all of us. Without your support as members and volunteers, SCA (Qld) would simply be unable to deliver what we do.

To that end we have embarked on an exciting program to deliver more member value than ever before which will see us delivering more. This strategic development program traverses our communications, our member resources and tools, our supplier benefits, our member benefits and our event and education offerings to ensure we are elevating the SCA (Qld) brand, our association, and our sector.

To support this focus, we have founded the Member Resources Committee in the past year with a commitment to ensuring that a variety of best practice guides for members. This additional practical insight will ensure that we continue to be up to date with modern body corporate management and underpin SCA (Qld) members being at the cutting edge of their profession.

We continue to partner with ACACIA EAP and HR Business Assist to ensure that both employer and employee members can manage their work in the best possible fashion. Recruiting new staff, and retaining existing staff, remains an industry wide challenge and we hope that these programs help member businesses in their endeavours in this regard.

Our new accreditation program continues to be popular, and we hope it will form the basis of the educational requirements for regulation of body corporate managers by Government in the medium term.

Overall, the SCA (Qld) membership offering continues to offer great value for strata managers and service providers alike.

SCA (Qld) had its biggest year ever in terms of advocacy success over the past twelve months, and we are delighted with the progress we have made for our industry and our members. As an organisation we must thank the advocacy team members who have been active over the past 12 months including the entire Legislation Committee, Jessica Cannon, Chris Irons, Jason Carlson, Duncan Lee, Peter Crogan and Shane Devenish who have all devoted their time, intellect and experience in an unwavering fashion to the advancement of our industry.

ADVOCACY

A highlight of course is the legislation of the Northern Australia Reinsurance Pool. This was the culmination of a decade of advocacy for our entire organisation and hopefully, the start of a positive and lasting change for our Northern members. It needs to be said just how involved SCA (Qld) was in finalising this pool and fighting for every last strata community in our North.

The exposure draft bill only covered in the more generous residential limb of the program strata properties which have more than 80% of their floor area being used for residential purposes. SCA (Qld) lobbied hard, and this was reduced to 50% floor coverage. Figures quoted in Senate Estimates indicate that this led to the coverage of an additional 6,000 properties by the pool. A big win for Queensland strata! Credit for this advocacy must be shared amongst various members of the Queensland board generally, but particularly Andrew Davidson, Chris Irons and Jason Carlson as well as former Directors Peter Crogan and Kelly Roberts who all contributed strongly to direct advocacy to Government and Opposition attending more than a dozen meetings between them.

SCA (Qld) also made several inroads in terms of pushing for an end to the epidemic of defective construction in the strata sector. SCA (Qld) sits on the Ministerial Construction Council sub-committee for reform of the Queensland Home Warranty Scheme and will push strongly in this space to have buildings over 3 storeys included. Just getting on this committee was a battle and credit must go to then President James Nickless for helping lead that fight.

Queensland apartment owners should have the same rights and protections as Queenslanders who live in detached dwellings. SCA (Qld) represents the entirety of the Queensland strata sector, including owners and we will fight for them all equally. We also were active in pressing the Government for rectification of dangerous combustible cladding and achieved quality media coverage in this space and had direct engagement with the relevant government department and parliamentarians.

The Community Titles Legislation Working Group took up a significant amount of intellectual energy and time for our advocacy team. Strong submissions were point together based on feedback from the board, Legislation Committee and members more generally. As an organisation we are providing strong thought leadership for all stakeholders on that Group and will continue to fight as hard as possible for our members. The Body Corporate and Community Management Act (1997) is 25 years old this year. This reform process is about bringing the law into the 21st Century. Professionalism, consumer protection and community autonomy will be the overarching principles which inform our ongoing advocacy in this regard. We will continue to make every post a winner and hope to see meaningful and long-lasting changes to the Act which help facilitate and vibrant strata sector for the next 25 years.

To ensure we captured the ideas of the widest spectrum of people across our industry, we ran our strata Hackathon which was a tremendous success, 61 people attended. We commend the synthesis of ideas that came out of this and will use these to inform our ongoing advocacy to Government.

SCA (Qld) has met with

the cross bench.

Through intelligently leveraging our non-partisan and diligent meeting schedule, our advocacy directors have gotten more discussion of strata in parliamentary debates and processes than ever before. We commend them for this as it gives us an opportunity to speak directly on behalf of the sector to parliamentarians and make them aware of the nuances and complexities of our industry.
